Legislature and Legislative Activities

- Approximately \$10 million added to the 2604 funding
- TAMFS increased 2604 funding Sept 1, 2023 to: \$140 per student/day; \$700 course max; \$15,000 annual department cap (at the urging of your SFFMA Executive Board and membership)
- Criteria for 2604 funding revised to include the age of equipment in qualifying for funding.
- Allowance for emergency transport of persons in non-EMS vehicles in certain circumstances.
- Increased penalties to drivers who do not move over for emergency vehicles.
- Creation of an industrial FF license plate.
- More temporary licenses allowed for bingo fundraisers by VFD's.
- · TUITION EXEMPTION FOR VOLUNTEERS
